

COOKIES POLICY

This Cookies Policy sets out the basis on which we, Virtusa Corporation (“Virtusa”), use cookies and similar technologies on or in relation to our website (<https://cdgm.virtusa.com/> and <https://cdeqm.virtusa.com/>) or Clinical Quality Measures Reporting solutions (collectively, our “website and solutions”). This Cookies Policy is effective from June 2024.

‘Essential’ cookies are automatically placed on your computer or device when you access our website and solutions or take certain actions on our website and solutions. ‘Non-essential’ cookies and other technologies are only placed on your computer or device if you have consented to us doing so. You consent to us placing non-essential cookies on your computer or device by continuing to use our website and solutions with your browser settings set to accept cookies. You can revoke your consent at any time by modifying your browser settings to refuse cookies. We will only keep cookies for as long as necessary to achieve the relevant purposes set out in this Cookies Policy.

This website and solutions are not intended for children under 16 years of age. We do not knowingly solicit data online from, or market online to, children under 16 years of age.

About cookies

What are cookies?

Cookies are small data files sent by server to a web browser, processor memory or hard drive and stored there. They can be used for a range of different purposes, such as customizing a website and solutions for a particular user, helping a user navigate a website and solutions, improving that user’s website and solutions experience, and storing that user’s preferences and login information.

Below you can find out more about the purpose of each type of cookies that we use.

- **Functional cookies** – These cookies enable the website and solutions to provide enhanced functionality and personalization. They may be set by us or by third party providers whose services we have added to our pages. If you do not allow these cookies, then some or all these services may not function properly.
- **Targeting cookies** – These cookies may be set through our website and solutions by our advertising partners. They may be used by those companies to build a profile of your interests and show you relevant adverts on other sites. If you do not

allow these cookies, you may still experience advertising, but the advertisements shown will not be personalized to you.

- **Strictly Necessary cookies** – These cookies are necessary for the website and solutions to function and cannot be switched off in our systems. They are usually only set in response to actions made by you which amount to a request for services, such as setting your privacy preferences, logging in or filling in forms. You can set your browser to block or alert about these cookies, but some parts of the site will not then work.
- **Performance cookies** – These cookies allow us to count visits and traffic sources so we can measure and improve the performance of our website and solutions. They help us to know which pages are the most and least popular and see how visitors move around the site. All information these cookies collect is aggregated and therefore anonymous. If you do not allow these cookies, we will not know when you have visited our website and solutions and will not be able to monitor its performance.

Cookies may be classed as first-party cookies or third-party cookies:

- First party cookies are those installed by us, and they are installed either for the time that you use our website and solutions, or they are stored longer to be used when you come back to use our website and solutions.
- Third-party cookies are installed by our partners and generally stay installed as you navigate the web. When you come back to our website or solutions, the cookies that we have installed on your device will be sent to our web server so the information can be accessed and reused.

We install both session and persistent cookies on your browser:

- A session cookie is only installed temporarily in a browser's memory and disappears once you close your browser.
- A persistent cookie is installed longer on your device. Persistent cookies are commonly used for web analytics which requires tracking visitor behaviour over different websites, as with Google Analytics. Web analytics does not allow websites to identify you individually as it uses tokens as an identifier or is provided as mass traffic. However, third parties who are permitted to install these cookies on our website and solutions, such as Google Analytics, may have access to more personal data about you.

Example of cookies used on our website:

Cookie List

A cookie is a small piece of data (text file) that a website or solutions– when visited by a user – asks your browser to store on your device to remember information about you,

such as your language preference or login information. Those cookies are set by us and called first-party cookies. We also use third-party cookies – which are cookies from a domain different than the domain of the website and solutions you are visiting. Some of the cookies we commonly use are listed below. This list is not exhaustive, but it is intended to illustrate the main reasons we typically set cookies. More specifically, we use cookies and other tracking technologies for the following purposes:

Strictly Necessary Cookies

These cookies are necessary for the website and solutions to function and cannot be switched off in our systems. They are usually only set in response to actions made by you which amount to a request for services, such as setting your privacy preferences, logging in or filling in forms. You can set your browser to block or alert you about these cookies, but some parts of the site will not then work. These cookies do not store any personal data.

How to accept or reject cookies

You can manage your preferences regarding cookies through your browser, however, if you decide to refuse all cookies (such as essential cookies), you may not be able to fully

benefit from our website and solutions. You can choose to deactivate cookies at any time on your browser. You can accept or delete cookies one by one or delete them systematically once and for all.

Cookie preferences must be set for each web browser. You generally have several ways to manage cookies, including completely authorizing or prohibiting cookies, deleting specific cookies that have already been saved by the browser, preventing certain websites from sending cookies to your computer, or blocking third-party cookies (when browsing on a website, cookies are sent to your computer by another website).

Some browsers, such as Chrome and Firefox, allow you to change your settings to browse in 'incognito' mode, limiting the amount of data placed on your machine and automatically deleting any persistent cookies placed on your device when you finish your browsing session. There are also many third-party applications which you can add to your browser to block or manage cookies.

Clearing existing cookies
